The Honourable Pro Vice-Chancellor welcomed all the members. Director, IQAC then brought up the agenda and the minutes of the 3rd IQAC meeting for confirmation followed by the day's Agenda.

CONFIRMATION OF MINUTES of the 3rd IQAC Meeting

The minutes of the 3rd IQAC meeting held on 14th June, 2019 were circulated among all members present in the meet for confirmation.

After thorough review, as per Agenda 1 of the 3rd IQAC meeting (Finalization of the various feedback formats), Director IQAC stated that changes have been made in the Teacher Feedback Form and presented the same in front the team members. The modified teacher feedback form was approved by all members present in the meeting.

As per Agenda 6 of the 3rd IQAC meeting, Director IQAC stated that some modifications were made to the Field trip/Technical tour forms which will be further discussed in the 3rd Agenda of this 4th IQAC meeting.

Remaining all other agenda of the 3rd meeting of the Internal Quality Assurance Cell were confirmed by the members.

AGENDA 1: Re-constitution of the IQAC member composition

The IQAC Chairman, Pro VC Prof. Subhasish Banerjee introduced Dr. Sanghamitra Kundu as the new IQAC Director to the team.

Since many of the IQAC team members have left the University, the IQAC team was reconstituted with new members and student's representatives as per the NAAC guidelines. The IQAC, Chairman, Director & Registrar, Brainware University (BWU) welcomed all the new members and expressed their vision that IQAC team will work and focus on Quality Enhancement (QE) activities of the University.

Director IQAC further informed that Prof. J.K. Mondal, Dept. of Computer Science and Engineering, Kalyani University will be the external Advisor for IQAC, BWU. It was further suggested that the Alumni member, the Industrialist and the Employer in the existing team also needs to be updated, as they haven't been able to attend any of the previous IQAC meetings due to their own schedules, which will be finalized in the next IQAC meeting.

AGENDA 2: Work Plan of IQAC

a. Annual report submission from various departments and divisions
